Art Sales Catalogues Online

Online access to complete Sales catalogues from 1600-1900

The *Art Sales Catalogues Online* (ASCO) publication offers easy access to complete historical art sales catalogues for the period 1600 to 1900. *Lugt's Répertoire online* database has been included in this publication and serves as the "entrance gate" to the catalogues.

The earliest art sales catalogues, also known as auction catalogues, appeared in the early 17th century, as simple leaflets. Over time, the catalogues grew into extensive, richly-illustrated publications. The catalogues are intriguing not only from the point of view of Art History, but also provide glimpses into the economic and sociological climate of the time.

Much research in the field of Art History relies on access to art sales catalogues. *Art Sales Catalogues online* providing access to thousands of complete sales catalogues from the period 1600-1900, combines a wealth of information from art sales catalogues with the reference facility of *Lugt's Répertoire*.

In his impressive four-volume work *Répertoire des catalogues de ventes publiques intéressant l'art ou la curiosité* ("Repertory of Catalogues of Public Sale concerned with Art or *Objets d'art*"), Frits Lugt (Amsterdam 1884–Paris 1970) covered the period 1600 to 1925. In *Lugt's Répertoire*, the catalogues are arranged in strict chronological order and provide meticulous details of auctions, as well as recording annotations written in the catalogues. Lugt also indicates the library where the catalogue may be consulted. The online edition of Lugt's work for the period 1600-1900 is the "entrance gate" to *Art Sales Catalogues Online*, but is also available as a separate online database.

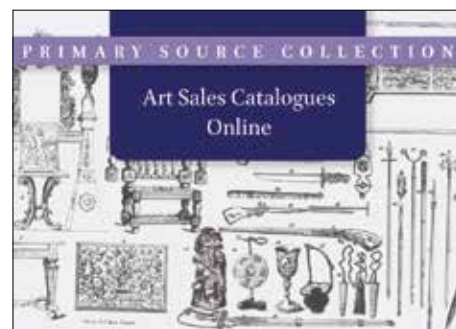
For ASCO the microfiches were digitized. Online editions of the catalogues are available for all catalogues available by BRILL. ASCO will be updated and supplemented regularly. Since 2011 we digitize the sales catalogues directly from the original print copy in full color.

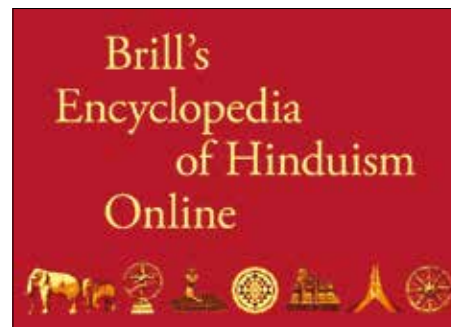

The North China Herald Online



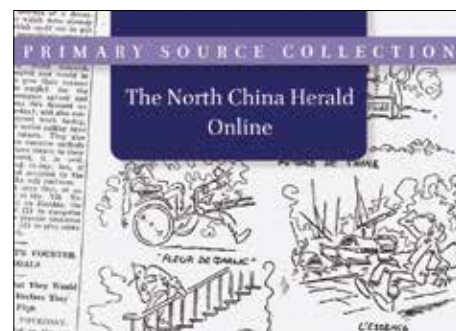

The English-language *North China Herald* is the prime printed source in any language for the history of the foreign presence in China from around 1850 to 1940s. During this so-called 'treaty century' (1842-1943) the Western Powers established a strong presence in China through their protected enclaves in major cities. It was published weekly in Shanghai, at the heart of China's encounter with the Euro-American world in a city at the forefront of developments in Chinese politics, culture, education and the economy. As the official journal for British consular notifications, and announcements of the Shanghai Municipal Council, it is the first -- and sometimes only -- point of reference for information and comment on a range of foreign and Chinese activities. Regularly it also features translations of Chinese official notifications and news.

The *Herald* had correspondents across the whole of China. These supplied a constant stream of news on an extensive range of topics, as well as news and gossip, such as, -- apart from news and gossip reflecting the social, cultural and political life of the foreign settlements--, trade statistics, stock prices, Chinese news, essays on Chinese culture and language, law reports from foreign courts in the settlements, company reports, news on foreign social, cultural and political life, maps, cartoons, photographs, stock prices and law and company reports, advertisements, tables of tea, silk and cotton exports, or long-forgotten facts about missionaries, birth, marriage, and death announcements. Its coverage extends well beyond British communities, and includes other foreign nationals - the French, Danish, Italian, German, Dutch..., etc., etc.

Although a thriving treaty port press developed over the century of the foreign presence, no other newspaper existed over such an extended period, and covers it in such incredible depth and variety. The dense unindexed columns of the *Herald* offer therefore an indispensable, still largely unexplored treasure-trove for any scholar of modern Chinese history.

War, revolution and politics have conspired to destroy library holdings or frustrate access to publications from China's treaty century. The *fully text-searchable North China Herald Online* will be one of the primary resources on a period which continues to shape much of China's world and worldview.

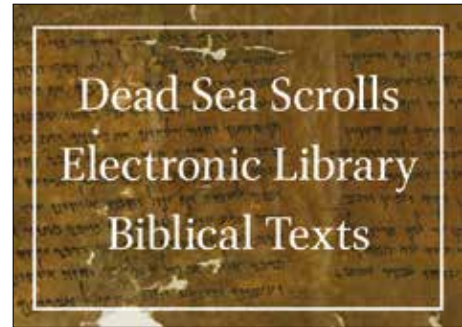

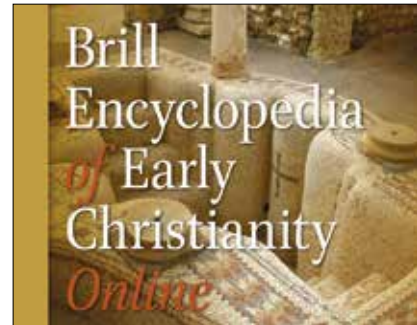

The *Brill Encyclopedia of Early Christianity (BEEC)* focuses on the history of early Christianity, covering texts, authors, and ideas. The *BEEC* aims both to provide a critical review of the methods used in Early Christian Studies and also to update the history of scholarship. The *BEEC* addresses a range of traditions, including iconographic, martyrological, ecclesiastical, and Christological traditions, as well as cultic phenomena, such as the veneration of saints. The history of the transmission of texts and the attention to recent scholarship will play an important role. The *BEEC* focuses on early Christianity from a historical perspective in order to uncover the lasting legacy of the authors and texts until the present day. Its content is intended to bridge the gap between the fields of New Testament studies and patristics, covering the whole period of early Christianity up to 600 CE. Currently only 330 articles are available.

The encyclopedia will consist of about 1300 articles. Every year about 300 articles will be added until planned completion in 2022. Once the online version is completed the encyclopedia will become available in print in 6 volumes.

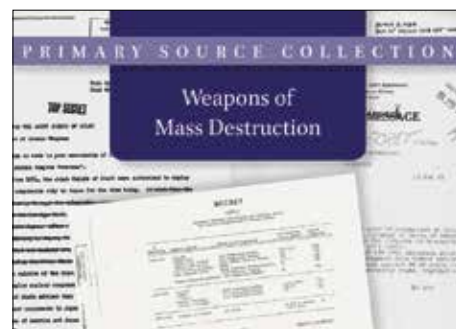
At its peak in 1967, the U.S. nuclear arsenal consisted of 31,255 nuclear weapons with an aggregate destructive power of 12,786 megatons – more than sufficient to wipe out all of humanity several hundred times over. Put together, they tell the story of how America secretly built up the world's largest stockpile of nuclear, chemical, and biological weapons. The documents explain the role these weapons played in a series of world crises, how they shaped U.S. and NATO defense and foreign policy during the Cold War, and what incidents and nearly averted disasters happened. Moreover, they shed a light on the dreadful human and ecological legacy left by decades of nuclear, chemical and biological weapons manufacturing and testing in the U.S. and overseas.

This collection contains more than 2,600 formerly classified U.S. government documents, most of them classified Top Secret or higher. Covering the period from the end of World War II to the present day, it provides unique access to previously unpublished reports, memoranda, cables, intelligence briefs, classified articles, PowerPoint presentations, military manuals and directives, and other declassified documents. Following years of archival research and careful selection, they were brought together from the U.S. National Archives, ten U.S. presidential libraries, the NATO Archives in Brussels, the National Archives of the UK, the National Archives of Canada, and the National Archives of the Netherlands. In addition, a sizeable number of documents in this collection were obtained from the U.S. government and the Pentagon using the Freedom of Information Act (FOIA) and Mandatory Declassification Review (MDR) requests.

This collection comes with several auxiliary aids, including a chronology and a historiographical essay with links to the documents themselves, providing context and allowing for easy navigation for both students and scholars.

Civil War and Its Impact on Women's Rights in South Sudan

While some advances have been made, civil war and political instability significantly hinder the improvement of women's lives in South Sudan.

South Sudan, the world's newest nation, has grappled with many problems since its birth—civil war, poverty, lack of development. It achieved independence from Sudan in 2011 following several decades of devastating civil wars. However, post-independence, civil war broke out in late 2013 and continues to wreak havoc on the nation.

Amongst the groups working towards rebuilding South Sudan are women's groups who are building the case for gender equality. In 2011, the new government granted a 15 percent affirmative action for women's representation—but the 2013 civil war ensured that the gains from such legislation did not reach the intended. A new study published in *Harvard's* *Brill* journal, argues that while some advances have been made, civil war and political instability significantly hinder the improvement of women's lives. At the same time, women's associations face challenges from the chaos war and inconsistent external funding.

Despite the appalling conditions of war and displacement as refugees and internally displaced people (IDPs), South Sudanese women have not succumbed to the challenges that they have faced in order to internally displaced people's camps. Rather, they have organized and campaigned for peace to prevail and to demand improvement in women's conditions in South Sudan and abroad, states the primary researcher Joan Edvard, Clinical Assistant Professor at Fordham University. 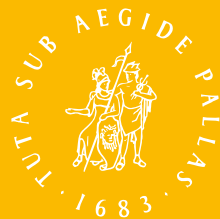
